Previously Recognition has been accorded to Jubilee EM High School, Gnanapuram, Visakhapatnam (UDISE Code:28132991190) to the classes VI to X (E.M.) from the academic years 2020-21 to 2022-23 vide reference 10th cited.

Further, the Commissioner of School Education, A.P., Amaravati has communicated the G.O. issued in the 13th cited vide reference 14th cited with instructions to extend the recognition of the schools from '3' to '8' years those who have already taken recognition for a period of '3' years to comply the orders dated.11.08.2023 of the Hon'ble High Court in W.P.No.18190 of 2023.

Now the Correspondent, Jubilee EM High School, Gnanapuram, Visakhapatnam (UDISE Code:28132991190) has submitted the application for extension of Renewal of Recognition for classes VI to X (E.M.) for the remaining five (5) years i.e., for the academic year from 2023-24 to 2027-28 vide reference 16th cited.

As per the instructions of the Commissioner of School Education, A.P., Amaravati vide reference 14th cited read with the G.O.13th cited and under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Visakhapatnam who is the competent authority hereby extends the Renewal of Recognition for the classes VI to X under E.M. in respect of Jubilee EM High School, Gnanapuram, Visakhapatnam (UDISE Code:28132991190) for the remaining period of five (5) years i.e., for the academic years from 2023-24 to 2027-28 without Grant-in-Aid now or in future subject to fulfillment of the following conditions.

- 1 That the society shall abide by the rules and regulations made by the Government or authorized officer from time to time.
- 2 That the Educational Institutions shall serve the needs of the locality more particularly.
- 3 The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 4 That the school timings, vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 5 That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed by the management with own funds as per the staff pattern.
- 6 That the results of institution shall be satisfactory every year.
- 7 That the records / accounts shall be furnished to the District Educational Officer, every year by

30th September at least.

- 8 That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 9 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 That all the conditions prescribed in the said G.O.'s and other orders which are not specified in this order shall be complied with.
- 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expiry of the present recognition.
- 14 The management is informed that no thatched roof accommodation is allowed to run the School.
- 15 The management shall provide proper adequate Toilets / sanitation facility to the students & Staff.
- 16 Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises.
- 17 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 18 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students.
- 19 The school shall have first aid kit and the teachers shall be trained in first aid.
- 20 That the management shall provide Ramps in the school building for differently abled children.
- 21 The management of the school is hereby instructed to maintain FIRE equipment in the prominent places of the school building as instructed by the Director General, State of Disaster Response and Fire Services, A.P., Vijayawada without fail.
- 22 That the management shall provide ramps for differently abled children in the school building.
- 23 That the management shall submit the TET Qualification Certificates of the Teachers appointed in the school to the District Educational Officer through the Inspecting Officer concerned without fail.
- 24 That the management shall provide the Annual Administrative Reports for all the years of previous recognition period and same should be submitted to the District Educational Officer through the inspecting officer.
- 25 That the management shall provide the Annual Audit reports of this school which were audited by an authorized Chartered Accountant for all the years of previous recognition period and same should be submitted to the District Educational Officer through the inspecting officer.
- 26 The Management is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
- 27 That the management shall meet the requirements from the fees collected from the students shall be allocated strictly as per the instructions of the Government and as per the sub rule (4) of rule 18 of G.O.Ms.No.1 Dated.01.01.1994.
- 28 The management shall submit the proposals for the recognition with in a stipulated time before expiry of recognition orders now issued through online only as per the Memo.No.ESE02-36/255/2020-COMM SE-CSE-Part(2), Dated.14.05.2023 of the Commissioner of School Education, A.P., Amaravati.

If the management fails to comply with the above conditions promptly the Recognition now granted will be reviewed. Receipt of these proceedings should be acknowledged.
